**ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Sajan Khabishow, New Bomdila, West Kameng District, Arunachal Pradesh for non-furnishing of information by the SPIO-cum-DFO(Khellong Forest Division), Govt. of A.P. o/o of Divisional Forest Office, Khellong, Bhalukpong, West Kameng District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 19/05/2023 regarding **Campa Fund under CA Plantation of the construction for 2880 MW Dibang Multipurpose Project by NHPC.**

The 2<sup>nd</sup> hearing is held today on 16<sup>th</sup> January' 2024 (Tuesday) at 1030 hrs. The PIO Shri Aduk Paron, DFO, Khellong Forest Division, Bhalukpong is present. The Appellant Shri Sajan Khabishow is absent. The PIO has submitted that in compliance with order passed by the Commission on the 1st hearing i.e 31<sup>st</sup> October'2023 the PIO made a communication to the Appellant to seek specific information for one specific work and for one financial year so that the case can be disposed of at the early vide his letter No. KD/33/2021/CAMPA/8017-08 Date 30/10/2023. But as on date no any reply has been received from the Appellant which it is presumed that he is not interested in the getting the information.

The Appellant is absent for 2 consecutive hearings as during the 1<sup>st</sup> hearing it was clearly directed both the parties to appear in the court failing which the case will be disposed of without any further notice, presuming that the Appellant is no more interested with the information sought for.

**Therefore, the case is disposed and closed.**
