This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Ashok Sangbia, Vill-Model Village Seppa, Po/Ps-Seppa, East Kameng District, Arunachal Pradesh, for non-furnishing of information by the Public Information Officer (PIO), O/o SE Kameng Basin Department of Hydro Power Development, Bomdila, West Kameng, District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 27/01/2026 regarding Category of all the Work Charged (W/C) staff serving under Bomdila SE Circle.
- 2). **The 3rd hearing was held on 18th August' 2026**, Er. Kipa Kaya, PIO-cum-EE (DHPD), O/o SE Kameng Basin Department of Hydro Power Development, Bomdila, West Kameng, District, Arunachal Pradesh was present. The Appellant, Shri Ashok Sangbia was absent.
- 3). The PIO submitted before the Commission a written reply for the Show Cause and also submitted a copy of Challan being fee for penalty.
- 4). The Appellant vide letter dated 28/07/2026 informed the Commission that the PIO had furnished him all the information and appealed to dispose of the case.
- 5). The Commission in view of the action taken by the PIO and satisfactory report of the Appellant decided to dispose of the case
