**ORDER**

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Ashok Sangbia, Vill-Model Village, Seppa, PO/PS Seppa, East Kameng District, Arunachal Pradesh, for non-furnishing of information by the Public Information Officer, Govt. of Arunachal Pradesh, Mowb-II, O/O SE PWD, Itanagar Highway Circle, Papum Pare District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 24/12/2025 regarding appointment of all the Work Charged (W/C) staff under the Circle of SE PWD, Itanagar, Highway.

2). **The 2<sup>nd</sup> hearing was held on 5<sup>th</sup> May' 2026.** Er. Nani That, Public Information Officer, Govt. of Arunachal Pradesh, O/O SE PWD, Itanagar Highway Circle, Mowb-II, Papum Pare District, Arunachal Pradesh was represented by Er. Kalyan Dutta, JE (PWD). The Appellant Shri Ashok Sangbia appeared before the Commission through online video conferencing.

3). The Appellant informed that information related to DPC and Recruitment Rule (R.R.) had not been furnished by the PIO.

4).The APIO submitted that the office of SE PWD, Itanagar Highway Circle, Mowb-II, Papum Pare District, Arunachal Pradesh had no record of DPC related information. Recruitment Rule (R.R. ) as sought by the Appellant at Form-A dated 24/12/2025 was not available with them. The APIO further stated that since the staff were transferred and posted from the office of SE (PWD) Daporijo Circle, the DPC details could be sought from them.

5). The Commission, in view of information furnished by the PIO and written statement vide letter No. IHC/E-43/2025-26/7 dated 20/04/2026, directed the Appellant to approach the office of SE (PWD) Daporijo Circle for the DPC related information. Also, apply afresh to the Department of Administrative Reform, Govt. of Arunachal Pradesh for the issues related to Recruitment Rules (R.R.). If required, the Appellant may appeal to the Commission under section 19(3) of the RTI Act 2005.

6). Since, the PIO had furnished the available information and given justifiable written statements to the Appellant, the Commission decided to dispose of the case.

**Therefore, the case is hereby disposed of.**
