ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI 2005. Brief fact of the case is that the Appellants Shri Ram Rime and Rapung Longu on **06/02/2023** filed an RTI application in Form- 'A' before the PIO-cum-Executive Engineer, Office of the Chief Engineer (Coordination) RWD, Itanagar, Papumpare District, Govt. of Arunachal Pradesh. Whereby seeking various information as quoted in Form 'A' application; The Appellants not being provided with the information by the PIO, filed the First Appeal before the First Appellate Authority (FAA) on **02/03/2023**. Appellants again having not received the required information from the FAA, filed the second Appeal before the Arunachal Pradesh Information Commission on **14/08/2023** and the Registry of the Commission (APIC) in receipt of the complaint registered it as **APIC- 754/2023 (Appeal)** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission on **03.12.2024, 13.02.2025 & 03.07.2025**. detail of information(s) sought from the PIO;

Furnish the certified true copies;

- 1) Newspaper clipping of an advertisement against the post of Junior Engineer (JE).
- 2) The publicized Gazette of Arunachal Notification with the counsel of Department of Administrative Reforms, Govt. of Arunachal Pradesh, against the above stated vide order number which is mandatory for Government Jobs, along with the website where it is uploaded.
- 3) File notings wherein how many posts were approved to be advertised for the post of Junior Engineer.
- 4) All applicants deposited treasury challans as an application fee in favor of the Superintending Engineer, RWD, Itanagar under the given head of account.
- 5) The total Nos. of appliers against the post of Junior Engineer with reference to the mentioned vide order number.
- 6) List of candidates as analyzed by the Board members along with the specific date of scrutiny.
- 7) All selected candidates as well as waiting listed candidates filled applications which tabled to the office of department concerned.
- 8) All rejected applications which submitted by the ineligible applicants for interview for the post of Junior Engineer.
- 9) The tracking IDs of speed post of the eligible applicants, call letters that mailed through Indian Post.
- 10) The name of examination/viva-voice superintending (ES) and invigilators/board members of while interviewing all participants.
- 11) All selected candidates, original education qualification for a snap-shot.

The Commission observes;

The Appellants Shri Ram Rime and Rapung Lamgu are absent for consecutive three hearings on 01.12.2024, 13.02.2025 and 03.07.2025. In all the hearings the Commission has issued notices to the Appellants to attend the hearing without fail and that the Commission clearly instructed that on the failure of the Appellants in the next hearing this instant appeal will be decided Ex-parte.

In the final hearing of the appeal 03.07.2025 both the parties are absent without intimating the Commission the reason for their inability to attend the hearing before the Commission.

And therefore, the Commission hereby orders;

The Appellants are not being serious on the appeal and are repeatedly wasting the precious time of the Commission as well as unnecessarily wasting the public resources incurred in sending notices to them. And therefore, this appeal is dismissed Ex-parte.

Order;

In view of the above facts and circumstance the Commission, finds this appeal fit to be dismissed and closed. And, accordingly, this Appeal stands dismissed ex-parte and closed once for all.


