JUDGEMENT ORDER

This is an appeal under section 19(3) of RTI Act, 2005 was received from Shri Raju Kyamdo, Polo Colony, Daporijo, Upper Subansiri District, Arunachal Pradesh, for non-furnishing of information, by PIO –cum- EE RWD, Daporijo, Upper Subansiri District, Arunachal Pradesh, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 27.04.2022 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

"Information sought against PMGSY Scheme for Rural Works under Siyum, Nacho CD Block for the period from 2018-2022"

The above subject has been mentioned in detail under 'Form – A'.

The 1st hearing of this case was held on 17.08.2022. The appellant was present, but the PIO was absent. The case was heard ex-parte. Since, the PIO was absent the case couldn't be discussed further. As such, the Court fix the next date of hearing of this case on 14.09.2022.

The 2nd hearing of this case was re-scheduled on 21.09.2022. Both the parties were absent. Hence, the case couldn't be heard. The Commission fix the next date of hearing of this case on 02.11.2022.

The 3rd hearing of this case was re-scheduled on 17.11.2022. The appellant was present, but the PIO was absent. The Commission seriously viewed the absence of the PIO without any intimation, nor he has deputed any representative to be present on his behalf to attend the case and to Show Cause as to why he should not be imposed with a reasonable penalty provided in Sub Section (1) of the Section 20 of having violated Sub-Section 01 of Section 7 of the RTI Act, 2005. Therefore the PIO is once again directed to appear in person on the next date of hearing of this case fix on 07.12.2022 alongwith all the information sought by the appellant.

The 4th hearing of this case was re-scheduled on 23.12.2022. Both the parties were present. Heard both the parties. Information sought by the appellant has been furnished by the PIO to the appellant during the hearing of this case. The appellant has been directed to go through the same and he should inform his satisfaction/dissatisfaction on or before the next date of hearing of this case fixed on 18.01.2023.

The 5th hearing of this case was held on 18.01.2023. The PIO was present, but the appellant was absent. PIO informed the Court that information sought by the appellant has already been provided to the appellant during the last hearing of this case. The appellant informed over phone that some clarification needs to be done from the PIO and later the doubts have been clarified by the PIO through telephonic conversation the appellant has pleaded for disposal of the case. Hence, the case is disposed of.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
