**ORDER**

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Chow Lajamang Mannow, Village Nanam Khamti, P.O. Manmow, Namsai District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE( PWD ), Govt. of A.P., Tezu Division, Lohit District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 05/03/2025 regarding **Improvement of District Headquarters Township roads at Tezu (under SASCI)**.
- 2). The 2nd hearing was held on 11<sup>th</sup> November' 2025 (Tuesday) at 1100 hrs. Er. Aiken Gohain - Cum- EE (PWD), Tezu Division, Lohit District was present through online mode. The Appellant Shri Chow Lajamang Mannow was also present during the court hearing.
- 3). The PIO-Cum- EE (PWD), Tezu Division, informed that the remaining information **Sl. No. (f),(h), (o) & (s)** had been furnished to the Appellant.
- 4). The Appellant Shri Chow Lajamang Mannow agreed that he had received the remaining information through the postal services and was satisfied with the information so furnished by the PIO and requested the Commission to dispose of the case.
- 5). When the Appellant requested permission for a site visit of work place, the Commission informed that since the area is in the open he could visit the project site on any given day.
- 6). Based on the input provided by the Appellant, the Commission observes it fit to dispose of the case.

**Therefore, the case is hereby disposed.**
