Relevant facts emerging from appeal.

RTI application filed on : 24.06.2025
SPIO replied on : not on record
First appeal filed on : 29.07.2025
First Appellate Authority's Order : not on record
Second Appeal filed on : 03.09.2025

Information sought:

The appellant filed an RTI application dated 24.06.2025 seeking information regarding W/C staff under RWD Singchung Division.

Details of information required: -

- Category of work charged (W/C) serving under your division and sub-division.
- Appointment letter of all the W/C staff serving under your division and sub-division.

- (c) Place of posting of all the W/C staff serving under your division and sub-division.
 - (d) Approval from competent Authority CE or SE, advertised details, Interview or viva voice detail, videography during written exam conducted, along with board formed then details of all the W/C staff recruited under your division and sub-division.
 - (e) Present strength of W/C staff under your division and sub-division.
 - (f) New strength of or against retirement or vacate of W/C staff under your division and sub-division.
 - (g) Total sanction strength of W/C staff under your division and sub-division.
 - (h) Recruitments rule (RR) of W/C staff serving under your division and sub-division.
- (4) Period for which information asked for: - 2018 to till date.

Appellant : Present. He states that he has received incomplete information from the PIO. He states that the information at serial no. (d) & (h) is not furnished to him.

Respondent PIO : Present through VC. He states that the information at serial no. (d) & (h) is not available in Singchung division office and he verbally advised the appellant to approach SE (Coord), Itanagar for the same.

F A A : Absent.

Decision:

The Commission after adverting to the facts and circumstances of the case, and perusal of the records and hearing the parties, observes that PIO has furnish all the information except following as per RTI application:

d) Approval from competent Authority CE or SE, advertised details, Interview or viva voice detail, videography during written exam conducted, along with board formed then details of all the W/C staff recruited under your division and sub-division.

(h) Recruitments rule (RR) of W/C staff serving under your division and sub-division.

Whereas, the PIO has stated that he is not the appointing authority for WC Cadre post and as such above information is not available with him and advised the appellant to approach the office of the Chief Engineer (Co-ordination) / Superintending Engineer (Co-ordination) for the same.

Whereas, it is notified in the implementation of RTI Act, 2005 in Arunachal Pradesh in F. No. AR-152/2010/228 Dated 18 November 2010 regarding Office Memorandum issued by Department of Personnel & Training, Govt. of India which States that " if a person makes an application to the public authority for information, a part of which is available with that public authority and rest of the information is scattered with more than other public authorities, the public information officer (PIO) of the public authority receiving the application should give information relating to it and advise the applicant to make separate applications to the concerned public authorities for obtaining the information from them.

In view of above the applicant is advised to make separate application to the Chief Engineer (Co-ordination) / Superintending Engineer (Coordination), RWD for information he has sought under serial number (d) and (h) in his RTI application.

This appeal case is closed in the commission.
