Information sought :

The appellant filed an RTI Application dated 21/04/2025 seeking Details regarding total strength of staff at Deomali Power Division,

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 05/03/2025. No hearing was conducted by the First Appellate Authority in his jurisdiction. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Animesh Kumar Mani **24/01/2025** filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer (Electrical) Deomali Division, Tirap District, Govt. of Arunachal Pradesh whereby, seeking various information,

as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **05/03/2025**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **28/04/2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 344/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 3(three) times i.e on 03/12/2025, 02/02/2026 and 20/05/2026. In this hearing of the appeal on **20th day of May, 2026**, Appellant Shri Animesh Kumar Mani present through VC but the PIO-cum-Executive Engineer (Electrical) Deomali Division found absent however, he sent a letter stating that the information sought by the appellant has already been provided. Appellant stated that he has received all the information and is satisfied.

Therefore, the appeal case is disposed of and closed.
