**JUDGEMENT/ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Tania June on 22.03.2022 filed an RTI application under Form-'A' before the PIO-Cum-EE, Deptt. of WRD, Pangin Division, Siang district, Boleng Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 23.05.2023, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 14.07.2023 and the Registry of the Commission (APIC), having receipt of the Complaint, registered it as **APIC No. 453/2022** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the **Commission for 12 (twelve) times i.e on 12.09.2022, 17.10.2022, 21.11.2022, 05.12.2022, 16.01.2023, 06.02.2023, 06.03.2023, 24.04.2023, 29.05.2023, 29.06.2023, 07.08.2023 & 25.09.2023. In this hearing of the appeal on 25<sup>th</sup> day of September,2023. The appellant present during the hearing but the PIO is found absent.**

**However, the appellant during the hearing submitted a letter to the Commission that he has received all the information as sought in the Form-' A' application and requested for disposal/closer of his appeal on the ground of satisfactorily receipt of all the information sought from the PIO.**

In view of the above facts and circumstances, I find this appeal fit to be disposed of and closed. And, accordingly, this appeal stands disposed of and closed for once for all.
