Information sought :

The appellant file a RTI Application dated 24/01/2025 seeking Details regarding 1. C/o Infrastructure development of JNV School Seppa including retaining wall. 2. C/o Play Ground at Dai Apung School Seppa to C/Tajo road.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 24/02/2025. No any hearing was conducted by the First Appellate Authority in his jurisdiction. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Mamu Sono absent.

Respondent : PIO-cum-EE(WRD), Seppa Division present in person.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Mamu Sono on **24/01/2025** filed an RTI application under Form-'A' before the PIO-cum-EE(WRD), Seppa Division, East Kameng District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO,

filed the First Appeal before the First Appellate Authority on **24/02/2025**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **28/03/2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 289/A/2025 & 292/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 3 (three) time i.e on 17/09/2025, 24/11/2025 and 16/03/2026. In this hearing of the appeal on **16th day of March, 2026**, PIO-cum-EE(WRD), Seppa Division, East Kameng District present but the appellant Shri Mamu Sono found absent without any intimation to the Commission.

As per the case record, the appellant was absent on the last hearing dated 24/11/2025. Last chance was given to the appellant to appear before the Commission. On the last 2 (two) hearings, the PIO has stated that the information were ready to be furnished but the appellant never came to collect inspite of informing.

Today the PIO has submitted a letter stating that the information sought by the appellant has already been furnished on 22/09/2026 and receipt copy is submitted before the Commission.

The appellant has also failed to intimate to the Commission in spite of giving him sufficient chance. Accordingly, the Commission deems fit to dispose of this appeal case. This appeal case is therefore disposed of and closed.
