**Information sought :**

The appellant filed an RTI Application dated 21/04/2025 seeking Details regarding C/o 132 KV transmission lines from New Seren to Niglok

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 02/06/2025. No hearing was conducted by the First Appellate Authority in his jurisdiction. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

**JUDGEMENT ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tohen Riram 21/04/2025 filed an RTI application under Form-'A' before the PIO-cum-DLRSO, Likabali, Lower Siang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application.

The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **02/06/2025**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **24/07/2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 595/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 3(three) times i.e on 19/11/2025, 28/01/2026 and 20/05/2026. In this hearing of the appeal on **20<sup>th</sup> day of May, 2026**, Appellant Shri Tohen Riram is represented by his Counsel Adv. T. Taggu but the PIO-cum-DLRSO, Likabali, Lower Siang District found absent without any intimation to the Commission. The appellant submitted in writing requesting to dispose of the appeal case No. 595/A/2025, as the sought documents have already been received from the PIO and is satisfied.

Request accepted and the appeal case is disposed of and closed.
