Information sought :

The appellant file a RTI Application dated 26/09/2023 seeking Details regarding Sewage Treatment Plant (STP) Project at Naharlagun.

As per the case record, PIO did not provide the sought information.

Being dissatisfied, the appellant filed First Appeal dated 01/09/2023. No hearing has been conducted by the First Appellate Authority in his jurisdiction. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Mamu Sono present in person.
Respondent : PIO-cum-EE (IMC, Pt. II), Naharlagun found absent.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Mamu Sono on **01.09.2023** filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer (IMC, PT. II), Naharlagun, Papum Pare District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **03.10.2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **06.11.2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 1028/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for eight times i.e on 02/12/2024, 13/01/2025, 24/02/2025, 26/03/2025, 28/04/2025, 18/08/2025, 29/09/2025 and 09/03/2026. In this hearing of the appeal on 9th day of March, 2026, the appellant Shri Mamu Sono but the PIO-cum-EE (IMC, Pt. II), Naharlagun found absent without any intimation to the Commission.

As per the case record, it is seen that the penalty imposed against the PIO has already been deposited and copy of the challan is submitted to the Commission. The information sought has also provided as stated by the appellant. Since it a long pending appeal case and information sought has also been provided, the case is deemed fit to be disposed.

Accordingly the appeal case is disposed of and closed.
