Information sought :

The appellant file an RTI Application dated 25/07/2025 seeking Details regarding List of project affected families/persons in connection with Dire-Dime to Moying Road (Dire-Dime) 0.00 km to Pangkang upto Siang Boundary 53 KM.

As per the case record, PIO did not furnish the information sought.

Being dissatisfied, the appellant filed First Appeal dated 11/09/2026. No hearing was conducted by the First Appellate Authority in his jurisdiction. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Ibrahim Takuk 25/07/2025 filed an RTI application under Form-'A' before the PIO-cum-DLRSA, Boleng, Siang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **11/09/2025**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **21/10/2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 782/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 1st time i.e on 20/04/2026. In this hearing of the appeal on **20th day of April, 2026**, the PIO-cum-DLRSA, Boleng and the appellant Shri Ibrahim Takuk found absent. However, the appellant has submitted a letter requesting to dispose of the case. Request accepted and the appeal case is disposed of and closed.


