The 2nd hearing is held today on 4th April, 2024 as scheduled. Shri Hibu Dolley, the PIOcum-DLRSO, DC Complex, Mini Secretariat Building, Po/Ps Roing, Lower Dibang Valley District, Arunachal Pradesh Pradesh and the appellant Shri Top Pertin are absent. Vide Memo No. DC-LDV-22023/1/2023/33-35 Dated Roing, the 28th March, 2024 it has been intimated to the Commission that Shri Hibu Dolley, the PIO-cum-DLRSO is actively engaged in election duty and unable to attend the hearing and requested to rescheduling he hearing date.
