### Appeal Under Section 19(3) RTI Act, 2005

### O R D E R

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Ms Bengia Mama, Dariya Hill Colony near Dony Polo Road, Itanagar, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-District Agriculture Officer, Govt. of A.P., Pasighat, East Siang District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 24/03/2025 regarding **Composite farming at Banguk cultivation area in East Siang District, Arunachal Pradesh.**

2). **The 1<sup>st</sup> hearing was held on 2<sup>nd</sup> September' 2025.** Shri Opang Moyong, PIO-cum-District Agriculture Officer, Govt. of A.P., Pasighat, East Siang District, Arunachal Pradesh had appeared before the Commission's court through Video Conferencing. The Appellant Ms. Bengia Mama was present in the court room in person.

3). The Appellant submitted that except for Sl.no. 19 of the Form-A dated 24/03/2025 she had been furnished with all other information. The PIO responded that since a Monitoring team was not deputed by the concerned department i.e. SJETA, Itanagar, hence the information sought at the Sl.no. 19 could not be furnished.

4). The Commission had directed the PIO to give correct authenticated statement through AFFIDAVIT and furnish the AFFIDAVIT to the Appellant with intimation to the Commission. The PIO vide letter no. ESA/RTI/2024-24/830-31 dated Pasighat the 4<sup>th</sup> Sept'2025 intimated the Commission of his action taken as directed and also submitted a C.T.C. copy of the AFFIDAVIT stating that :-

*"That as per official records of o/o the District Agriculture Officer, East Siang District, Pasighat, visit of Project spot / monthly monitoring of Composite Farming at Banguk Cultivaiton area in East Siang District, Arunachal Pradesh is not on record".*

5). The Commission finds that the PIO has done his duty diligently in providing the requisite AFFIDAVIT and therefore decides to dispose of the case.

6) Therefore, the case is hereby disposed of.


