JUDGEMENT ORDER

An appeal under section 19(3) of RTI Act, 2005 was received from **Shri Tali Umbey, S.D & Reks's Associate, Alexander House, Mowb-I, PO/PS- Itanagar, District – Papumpare, PIN- 791111, Arunachal Pradesh**, for non-furnishing of information, by **The PIO -O/o The Directorate of Tourism, Itanagar, District – Papumpare, PIN-791111, Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 14.11.2022 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding :

"a) Furnish the list of the scheme sanctioned during FY- 2021-22 with respect to 42nd constituency, Lower Dibang Valley Dist.AP. b) Furnish the fund allocated under 42nd (ST) AC in particular."

The above subject has been mentioned in detail under 'Form – A'.

The 1st hearing for the case was held on 03rd day of May' 2023. Both the parties were present. Heard both the parties. The appellant informed the Court that the documents furnished by the PIO were incomplete and invisible. The PIO pleaded before the Court for few days time to furnish the complete documents. The Court directed the PIO to furnish the remaining documents to the appellant on or before the next date of hearing. Accordingly, the Court fixed the next date of hearing on 17th May' 2023.

In-between, in the month of May' 2023, the appellant informed the Commission that he has received all the documents from the PIO and expressed his satisfaction for all the documents received and later pleaded for disposal of the case. In this view, the case is disposed off and no such hearings for this case will be entertained further in the Commission's Court.

Considering all the above aspects into account, I find this appeal fit to be disposed off as infructuous. And, accordingly, this appeal stands disposed off and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
