**JUDGEMENT**

This is an appeal filed under sub-section (3) of Section 19 of the RTI 2005. Brief fact of the case is that the Appellant, Shri Sartam Magia on **10/06/2025** filed an RTI application in form 'A' before the PIO-cum-Executive Engineer, RWD, Jamin Division, Palin, Kra-Daadi District, Govt. of Arunachal Pradesh. Whereby seeking various information as quoted in his Form 'A' application. The Appellant being not satisfied with the information received from the PIO filed the First Appeal before the First Appellate Authority (FAA) on **16/07/2025**. Appellant again not satisfied with provided information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **29/08/2025** and the Registry of the Commission (APIC) having receipt of the Appeal registered it as APIC- No. **664/A/2025** (Appeal) and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission on **12.03.2026** wherein both the parties present in person during the hearing before the Commission.

**Details of Information sought from the PIO;**

- i) Furnish the sanction order copy.
- ii) Furnish the DPR copy.
- iii) Furnish the Technical Sanction copy.
- iv) Furnish the utilization certificate (UC).
- v) Furnish the agreement copy between contractor and executing agency.
- vi) Furnish the payment details against the work.
- vii) Furnish the MB record.
- viii) Furnish the Muster Roll.
- ix) Furnish the Geotag with colour photos.
- x) Furnish the colour photo before and after completion of work.

**Period for which information required:-** Since from start of work to till date.

The first and final hearing held today on 12.03.2026 related to APIC-No. 664/A/2025, the Appellant present during the hearing before the Commission.

The PIO is represented by Shri Byabang Takar, who is the APIO of the office of the PIO.

**Heard the Appellant;**

The Appellant stated that he has been provided with the information(s) as applied but he is not satisfied with some of the information(s) especially the balance of the fund because the work physically has not been carried out as per the funds spent.

**Heard the APIO;**

The APIO stated that whatever information(s) the Appellant sought have been furnished to the Appellant completely.

After hearing both the parties, the Commission hereby observes;

i) The admission of the Appellant that he has been provided the information(s) by the PIO though he is not satisfied with the particular information(s) cannot be helped by this Commission, as this Commission is not empowered with investigation and try corruption issues and the statement by the APIO that all the information(s) have been provided simply satisfies the procedural laws under the RTI, Act, 2005.

Under the above statement of the Appellant as well as APIO, the Commission hereby decides;

i) The furnishing of the complete information(s) by the PIO to the Appellant satisfies this Commission to dispose of this appeal and close it.

**Order:**

In view of the above facts and circumstances the Commission, find this appeal fit to be disposed of and closed. And accordingly this appeal stands disposed of and closed once for all.
