ORDER

This is a complaint under Section 18(1) of RTI Act, 2005 filed by Shri Tania June, E-Sector Naharlagun, Po/Ps Naharlagun, Arunachal Pradesh, for non-furnishing of information by Shri Joram Uku, PIO-cum-EE(PWD), Govt. of A.P., Public Works Department, Dirang Division, West Kameng District, Arunachal Pradesh, as sought by the complainant under Section 6(1) of RTI Act, 2005 vide Form-A Dated 12/09/2024 regarding details of staff engaged under Group B/Group C/ WCT R / UDC / LDC / PEON / Driver / Contingency / all MTS Post etc.
- 2). The 2nd hearing was held on 20th January, 2026. Shri Joram Uku, PIO-cum-EE(PWD), Govt. of A.P., Public Works Department, Dirang Division, West Kameng District, Arunachal Pradesh was represented by the APIO, Er. Tapi Mali, AE (PWD) Dirang. The Complainant Shri Tania June was represented by Shri Donik Roru.
- 3). The APIO had informed the Commission that the information sought by the Complainant were kept ready and that the Complainant could collect the same from the office.
- 4). Thereby, the Complainant was directed to collect information from the office of the PIO within fifteen days from the date of issue of the order dated 20th January'2026. The Commission had also directed the Complainant to intimate his satisfaction or dissatisfaction after receipt of information but till date Complainant had not provided any input.
- 5). Therefore, the Commission in larger public interest and in view of the order dated 20th January'2026 decided to dispose of the case.
- 6). Therefore, the case is hereby disposed of.
