**JUDGMENT/ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Ha Tago & Shri Sartam Tallu on 18/07/2023 filed an RTI application under Form-'A' before the PIO-Cum-DDSE, Yupia, P/Pare District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 03.09.2023 Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 29.01.2024 and the Registry of the Commission (APIC), having receipt of the Complaint, registered it as **APIC No. 69/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for once i.e on 19.03.2024. In this hearing of the appeal on 19<sup>th</sup> day of March,2024. The appellant Shri Ha Tago present during the hearing but the PIO found absent. However, the PIO detailed his representative namely Shri Nabam Tagio , Coord (Estt).

Heard both the parties.

The representative of the PIO intimated to the Commission that he has brought all the information as sought by the appellants in their form 'A' application.

Accordingly. the appellant receive the said information before the Commission and after going though the information, the appellant intimated to the Commission that they have received all the information as sought in the Form-' A' application and requested for disposal/closure of their appeal on the ground of satisfactory receipt of all the information sought from the PIO.

In view of the above facts and circumstances, I find this appeal fit to be disposed off and closed. And, accordingly, this appeal stands disposed off and closed once for all.
