Information sought :

The appellant file an RTI Application dated 20/07/2024 seeking Details regarding furnish all the relevant information against the Project P/W/S to Kombo Tarsu Mobuk-III Village for the year 2022-2023.

As per the case record, PIO has conducted hearing under his jurisdiction on 09/08/2024.

Being dissatisfied, the appellant filed First Appeal dated 24/03/2025. No hearing has been conducted by the First Appellate in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Kimin Ingo absent.

Respondent : PIO-cum-EE (PHE & WS), Aalo Division absent.

JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Kimin Ingo on **18.10.2024** filed an RTI application under Form-'A' before the PIO-Cum- Executive Engineer (PHE & WS), Aalo Division, West Siang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **20.10.2024**. Appellant. again having not

received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **27.11.2024** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 370/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for three time i.e on 21/05/2025, 11/08/2025 and 03/09/2025. In this hearing of the appeal on 3rd day of September, 2025, PIO-cum-EE (PHE & WS), Aalo Division and the appellant Shri Kimin Ingo found absent without any intimation to the Commission.

As per the case record, on the last hearing dated 11/08/2025 both the parties were present. The PIO has stated that the information sought at Sl. No. 6 & 9 will be provided within 15 (fifteen) days from the date order. The appellant also agreed to collect the information from the PIO's office. The appellant was directed to intimate to the Commission after getting the information. If no intimation is made, the Commission will deem that information sought has been provided and he is satisfied.

Today the appellant is absent without any intimation to the Commission. Therefore, the Commission deems that information sought has already been collected by the appellant and he is satisfied. The appeal case No. 370/2024 is therefore, disposed and closed.
