JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Riya Taram, Bengia Tahar & Lokam Namdu on 20/01/2025 filed an RTL application under Form- 'A' before the PIO-cum-Executive Engineer, Dept. of Electrical Division Miao, District:-Changlang, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 26/02/2025, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 08/04/2025 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No-309/A/2025(Appeal)** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for first time i.e on 08/09/2025. In this hearing of the appeal on 8th day of September, 2025, the appellant Shri Riya Taram absent and the PIO-cum-Executive Engineer Dept. of Electrical Division Miao, Changlang District present through VC. However, a request letter received from the appellant Shri Riya Taram for disposing of the appeal case No.**APIC-309/A/2025(Appeal)**.

Request is accepted and the appeal case No APIC-309/A/2025 disposed and closed.
