**An Appeal Case U/S 19(3) of RTI Act, 2005**

**Case No. APIC- 867/2025.**

**APPELLANT** : Miss Bengia Mama, Dariya Hill colony, Itanagar.

**RESPONDENT** : The PIO, o/o the Chief Engineer (PWD), CSQ, Nirman Bawan Itanagar.

**ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Miss Bengia Mama for non-furnishing of below mentioned information by the PIO, o/o the Chief Engineer (PWD), CSQ, Nirman Bawan Itanagaras sought for by her under section 6(1) (Form-A) of RTI Act, 2005 vide her application dated 31.07.2025.

**Details of information required:**

4. Furnished a copy of the list of Contractor Enlistment of Arunachal Pradesh.
5. Furnish a copy of the APPWD Englishmen rules, 2008/2022.
6. Furnish all the copies with proper CTC.

**Period for which information asked for:** in regarding as per information sought.

**Brief facts emerging from the appeal and decision:**

The records reveal that the Appellant, Ms. Bengia Mama had filed application dated 31/07/25 before the PIO o/o the Chief Engineer, PWD, CSQ, Nirman Bhawan, Itanagar, Arunachal Pradesh requesting for information(s). But, apparently, having failed to receive the information(s) from the PIO, the Appellant had filed First Appeal under Section 19(1) of the RTI Act, before the First Appellate Authority (FAA), the Chief Engineer (PWD), CSQ, Nirman Bhawan, Itanagar , AP, vide Memo of Appeal dated 22/09/2025.

Records further disclose that the FAA had conducted the hearing on 17.11.2025 and passed the following order:

**“ORDER**

1. *The fact of the case is that vide No. Nil dated 31/07/2025 and received in this office on 10/08/2025, the appellant Miss Bengia Mama sought some information pertaining all Class I, IA & IAA Class-II, Class-III Registered Contractor of Arunachal Pradesh.*
2. *Not satisfied with the information/communication furnished by the PIO, the appellant vide No. Nil dated 22/09/2025 and received in this office on 29/09/2025 appealed to the First Appellate Authority under Section 19(1) of the RTI Act 2005.*
3. *The applicant is seeking to be provided with some documents submitted by the concerned firm in this office.*

4. *This office is of the view that the PIO should provide information/furnish relevant documents to the Appellant except those covered under section 8 (1) (d), 8 (1) (j) and 11(2) of the RTI Act, 2005.*
5. *As such. PIO under section 8 (1) (d). 8 (1) (j) and all relevant sections of the RTI Act 2005, is of opinion that the documents sought by the RTI applicant doesn't serve any larger public interest and has therefore decided not to disclose documents sought to the RTI applicant without the consent of the third party. However the information regarding Enlistment list and Enlistment Rule 2008/2022 is available for disclosure on website [www.aruanchalpwd.org](http://www.aruanchalpwd.org) which is in public domain.*
6. *However, the Appellant is at liberty to further appeal to the State Information Commissioner if not satisfied with this order.*

*With this, the Appeal stands disposed off.*

The Appellant, dissatisfied with the order of the FAA as above, preferred this Second Appeal before this Commission under Section 19(3) of the RTI Act, 2005 vide memo dated 24/11/2025.

This appeal is, accordingly, listed today on 08.04.2026 wherein the appellant, Ms. Bengia Mama is present in person while the PIO, Er. Shri Moji Padu, EE (CSQ) is present through VC.

Heard the parties.

The appellant, reiterating her demand for the requested information, pleaded for an appropriate direction to the PIO to furnish the information. The PIO, on the other hand submitted that he had joined the department recently and therefore is not well versed with the facts of the case/appeal on hand.

This Commission, upon perusal of the FAA's order dt.17.11.2025 as above, concludes that the denial of the requested information on the ground that these are available on website was not proper as the applicant has requested for the documents duly certified by the PIO.

This Commission concludes that since the requested documents are not exempted but maintained for public purpose, the same shall be furnished to the appellant duly certified by the PIO within 1(one) week from the date of receipt of this order.

This appeal is disposed of and closed with the above direction.
