**JUDGMENT**

This is an appeal filed under sub-section (3) of Section 19 of the RTI 2005. Brief fact of the case is that the Appellant, Shri Ashok Sangbia on **24/10/2025** filed an RTI application in form 'A' before the PIO-cum-Executive Engineer (EE), WRD, Bomdila Division, West Kameng District, Govt. of Arunachal Pradesh. Whereby seeking various information as quoted in Form 'A' application. The Appellant being not receiving the information from the PIO filed the First Appeal before the First Appellate Authority (FAA) on **03/12/2025**. Appellant again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **16/01/2026** and the Registry of the Commission (APIC) having receipt of the Appeal registered it as APIC- No. **152/A/2026** (Appeal) and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission on **26.05.2026 & 04.08.2026.**

**Details of Information sought from the PIO;**

- i) Certified copy of Category of all the work charged (W / C) staff serving under your division and sub-division.
- ii) Certified Copy of Appointment letter of all the W/C staff serving under your Division and Sub-Division.
- iii) Certified Copy of Place of posting of all the W/C staffs serving under your Division and Sub-Division.
- iv) Certified copy of DPC Board member officers name & designation along with trade test (TT) marks details of all the W/C staff recruited serving under your Division and Sub-Division.
- v) Certified copy of approval from competent authority CE/SE of all the W/C Staff recruited/Advertised under your division & sub-division.
- vi) Certified Copy of present strength of all the W/C staff under serving your Division and Sub-Division.
- vii) Certified Copy of new strength of or against retirement or vacate of all the W/C staff serving under your division and sub-division.
- viii) Certified Copy of total sanction strength of all the W/C staff serving under your division and sub-division.

- ix) Certified copy of Recruitments rule (RR) of W/C staffs' approval from Administrative Reforms (AR) Department Govt. of (A.P).
- x) Certified copy of attendance register of all the W/C Staffs serving under your division & sub division.
- xi) Certified Copy of Service identity card sign & seal of competent authority along with active contacts No. of all the W/C staff serving under your division and sub-division.
- xii) Certified copy of Officer name & working contact Number of Chief Engineer and Superintending Engineer who appointed to all the W/C Staff serving under your division & sub-division.
- xiii) Certified copy of E-Data of all the W/C staff serving under your division and sub-division.
- xiv) Certified copy of Joining Report of all the W/C staff serving under your division and sub-division.
- xv) Certified copy of all the supporting documents like ST, SC, OBC, PRC, Aadhar card, educational qualification etc. of all the W/C Staff serving under your division and sub-division.
- xvi) Certified copy of Date of Retirement (DP) of all the W/C staff serving under your division and sub-division.
- xvii) Certified copy of those employees who transferred from other district under Arunachal Pradesh to all the W/C Staff serving under your division and sub-division.

**Period for which information asked for: -2016 to till date**

In the second hearing held today on 04.08.2026 the Appellant is present through online mode during the hearing before the Commission.

The PIO-cum-Executive Engineer (EE), WRD, Bomdila Division, West Kameng District, Govt. of Arunachal Pradesh is represented by Shri Debia Kojum, APIO-cum-Assistant Engineer, WRD, Bomdila Division, Govt. of Arunachal Pradesh during the hearing before the Commission.

After hearing the APIO, the Commission hereby observes;

- i) The Appellant was absent in the first hearing held on 26.05.2026 despite notice being served for the hearing on 19.03.2026.
- ii) The Appellant is present through online mode today and had he been present in the court today in person the APIO could have provided him the information(s) copies.
- iii) The Commission briefed the Appellant regarding the information copies being brought to the court by the APIO repeatedly and had the Appellant been present the information(s) could have been handed over to the Appellant by now/today.

**In the absence of the Appellant in the court in person the Commission hereby order as follows;**

- a) The Appellant to collect the information(s) from the office of the PIO in person.
- b) As the PIO has been continuously attending the hearing along with the information(s) copies readied to be handed over to the Appellant, the Commission order the PIO to furnish the information to the Appellant when the Appellant presents himself at the office of the PIO in person.

- c) The Commission after informing that the information are ready to be furnished to the Appellant, there is no further need to prolong hearing this appeal, to which the Appellant also agreed, and therefore, the Commission does not see the reason to prolong this hearing of the appeal, and hence, dispose of this appeal and close it once for all.

Under the above observations and circumstances the Commission, find this appeal fit to be disposed of and closed. And accordingly this appeal stands disposed of and closed.
