ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Adv. Riya Taram, C/o Riang Store near Catholic Church Jollang, Itanagar, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-Executive Engineer, Hydropower Bordumsa Division, Changlang District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 13/06/2025 regarding details of information for scheme under (RE/BE) during 2023-2025 .
- 2). **The 1st hearing was held on 10th March' 2026.** Er. Jumbom Geyi, PIO-cum-Executive Engineer, Hydropower Bordumsa Division, Changlang District, Arunachal Pradesh appeared before the court through Video Conferencing. The Appellant Adv. Riya Taram was absent.
- 3). The PIO informed the Commission that on 22/07/2025 Appellant was served with a letter intimating him to collect information from the office but the Appellant did not turn up. The First Appellate Authority (FAA) also on 09/09/2025 had directed the Appellant to collect information but the Appellant failed to turn up; the information are kept ready to be furnished.
- 4). Since, the Appellant is absent without any intimation, the Commission in view of the caution in the hearing notice, decides to dispose of the case.
- 5). **Therefore, the case is hereby disposed of.**
