JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Chou Chali Simit on 22/07/2025, filed an RTI application under Form-'A' before the PIO-Cum-EE, Department of (RWD.) Namsai Division, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 021/09/2025 the Appellant again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 08/12/2025, and the Registry of the Commission (APIC), having receipt of the Appeal registered it as APIC No. 894/2023 (Appeal) and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for the 1st hearing held on 5/3/2026.

Details of information sought by the Appellants

- viii) Certified True Copy of Letter of Acceptance, Letter of Award and Agreement between con Engineer and the Firm owner/proprietor or Power of Attorney (POA) who won the Tender.
- ix) Certified True Copy of No near relative(s) certificate i.e EE/AE/JE working under PWD, Na Division.
- x) Mentioned in the First & Final bill. Certified True Copy of the details of Payment done through cheque / PFMS/RTGS/DSEPOEL.
- xi) Certified True Copy of the board members of the Tender processing.
- xii) Certified True Copy of Geo-tag, GPS Co-ordinates, videography, photography (Glossy paper the said Work, before starting, ongoing and after completion of the said work.
- xiii) Certified True Copy of Original Copy of turnover Certificate for the last 5 years 1 Chartered Accountant mentioning the UDIN number of the tender winning Firm.
- xiv) Certified True Copy of Utilization Certificate Signed by EE,SE, SF&AO,CE(EZ) PWD, Co Statement and Completion report of the work.
- xv) Certified True Copy copy of Contractor Enlistment update reports, GST res certificate. past work completion certificate, PAN, Phone Number, Income tax c certificate, latest audit report of last 3(three) years duly certified / audited by the c Accountant of the firm who did the work/scheme.
- xvi) Certified True Copy of Existing Commitments & Ongoing Work of the Firm who did the V
- xvii) Certified True Copy of names of the EE,AE,JE who executed the said work along with numbers.
- xviii) Certified True Copy of Cashbook statements with page number and Give hand recieved Payee name of the said Work.
- xix) Certified True Copy of name of Sub-contractor ile Shri Ashok Tripathi with Aadhar can number.
- xx) Certified True Copy of LOC Copy.

Period of which information asked for:-From 2023-TILL DATE

Other Details - Inspection of Work, document and record Under Section 2(j) of RTI Act be assisted by the concern EE/AE/JE of the said Work.

In the 1st hearing on 5th day of Feb '2026, the representative of the Appellant Shri Chow Lajamang Mannow , present during the hearing with an authorization letter from the Appellant and the PIO –cum, Executive Engineer (RWD), Namsai Division present during the hearing.

1. The PIO to provide all remaining information(s) as listed under serial no.B to the Appellant and the Appellant to receive the information.
2. The Appellant received all the remaining information inside the court of the Commission.

Under the above stated observations that the Commission does not need to further hearing of this appeal, and therefore, disposed this appeal.

In view of the above, facts and circumstances the Commission, find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed of and closed once for all.
