JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellants Shri Riya Taram, Shri Lokam Tadam & Takam Sakap on 17/08/2023, filed an RTI application under Form-'A' before the PIO-Cum- EE, Power Division Yazali, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellants, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 17/9/2023, the Appellants again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 08/01/2024 and the Registry of the Commission (APIC), having receipt of the Appeal registered it as APIC No 114/2024(Appeal) and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 7 (seven) times i.e on 07/05/2024, 06/06/2024, 06/08/2024, 26/11/2024, 04/02/2025, 08/04/2025 & 09/09/2025

Details of information sought by the Appellants.

1. Particulars of information: To furnish all the Relevant information of Entire Power/Electrical Palin Division Regarding the Allocation Fund under SIDF/UNTIED Fund/integrated Power development Schemes (IPDS)/North Eastern Region power System improvement Project (NERPSIP)/MLALAD/BE/RE/SADA Scheme for implemented/Expenditure for
2. Maintenance of power/ line and Supply of all Equipment and Materials/other Civil works/electrification.
3. .Extension/Renovation/Augmentation/improvement/Repairing of HT/LT Lines/or Construction of LT Line i/c Up gradation of Sub-station/division HT Line power/Distribution transformers/replacement of corroded poles/set up Security fencing to all the electrical sub-division./Strengthening and Re-alignment of HT/LT Line Supply & Installation of Street light work from 2014 to till date

All the documents must be furnish separately in scheme wise or year wise. Or CD Block wise.

- (a) Concern department Electrical/Power Palin Division.
- (b) Details of information Required:-

1. Maintenance of Power/light/ Line Supply under above mentioned Scheme

- (i) Give the DPR/Technical Sanction (TS) /Work Order copy/Govt. Sanction order and Amount of above mentioned scheme.
- ii) Give the name of Contractor/Firm/Enterprises/Suppliers /NGO/CBO/individual with their Bank Account Number whom the bill has been passed/transferred.

- iii) Give Cheque leaf/ cheque book Counterfoil and serial numbers/demand draft/banker cheque/Billing challan/cash memo/Money Receipt of above mentioned scheme.
- iv) Give the Measurement Book (MB) with MB Numbers and Page Numbers/Cash memo/Voucher/Cash book with page number/billing /Treasury Challan of above mentioned schemes.
- v) Give the First and Final Bill copy/Hand Received with payees Name/tender order/Quotation order.
- vi) Give the Photocopy of all the Worksite with GPS co-ordinates.
- vii) Furnish the Certified Copy of LOC/LOA which Received from finance department /Chief Engineer Office.
- viii) Give Tender agreement and tender floating details or publication date and websites of above mentioned schemes. Or Video Recording/photograph of tender committees with date.
- ix) Details of all related corresponding official Letters of above mentioned Schemes from junior Engineer level to Chief Engineer Level.

2. Regarding the Electrical Equipment and Materials Supply Implement under above mentioned Schemes:

- i) Give DPR/Technical Sanction (TS)/Work Order/Govt. Sanction order/sanction Amount /Estimate Copy of above mentioned scheme. Or Give Name of work.
- ii) Give the name of contractor/Firm/ Enterprises/ Suppliers /NGO/CBO/individual with their Bank Account Number whom the bill has been passed.
- iii) Give Cheque book counterfoil/leaf and Serial number of above mentioned schemes/demand draft/Bankers Cheque of above mentioned Schemes.
- iv) Give Measurement Book (MB) MB Number and with Page Number/Cash Memo/Money Receipt of every Materials/items/Voucher/Billing challan/Cash book with page number.
- v) Give the First and Final Bill copy/Hand Received with payees Name/Tender order/Quotation order.
- vi) Furnish the Photocopy of all the worksites with GPS Co-ordinates.
- vii) Furnish details Certified Copies of LOC/LOA received from finance department/Chief Engineer Office of the above mention period.
- viii) Furnish NIT Copy
- ix) Give the Video Recording/Photograph of Tender Committees.
- x) Give the details of Tender agreement copy and tender floating details or Publication date and websites of above mentioned schemes.
- xi) Details of all related corresponding official letters of above mentioned schemes from junior engineer level to Chief Engineer level.

3. To Furnish the information Regarding Civil Work and other Electrical/Power works under SIDA/Untied Fund/IPDS/NERPSIP/SADA/BE/RE Schemes:

- i) Furnish Detail of Project Report (DPR)/Technical Sanction (TS) / Work order copy /Name of Work/Project with mentioned the Exact Location of Particular work.
- ii) Govt. Sanction order and Sanction Amount copy. Or Give the Name of Work.
- iii) Give the name of contractor/Firm/Enterprises/NGO /Firm/Enterprise/NGO/CBO/individual with their Bank Account Number whom the bill has been passed/transferred.

- iv) Give cheque leaf/Cheque book counter foil and serial numbers /demand draft/Banker cheque/Billing challan of above mentioned schemes.
- v) Give the Measurement Book (MB) with MB Numbers and page Number/cash memo/Money Receipt with contain proper seal of every materials/item/ Cash book with page Number of above schemes.
- vi) Give the First and Final Bill copy./Hand Received with payees Name.
- viii) Furnish Photocopy of Every worksites with GPS Co-ordinates. Give the Certified copy of LOC/LOA Received from Finance Department/Chief Engineer Office.

In the 7th hearing on 9th day of Sept '2025, the Appellants found absent but a letter dated 09/09/2025, submitted to the Commission during the hearing. The PIO –cum, Executive Engineer (Power) found absent during the hearing without intimating the reason for his inability to attend the hearing.

However, the Appellant Shri Riya Taram, has submitted a letter to the Commission on 09/09/2025 stating that they have received all the information(s) as sought in their Form 'A' application and has requested the Commission for disposal/closure of their appeal on ground of completely in receipt of all information(s) sought from the PIO.

In view of the above, facts and circumstances the Commission, find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed of and closed once for all.
