**Information sought :**

The appellant file an RTI Application dated 14/12/2022 seeking Details regarding materials procure and supply of MGNREGA and staff wages at Lemiking , CD Block, Upper Subansiri District.

As per the case record, PIO has never conducted hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 19/01/2023. No any hearing has been conducted by the First Appellate Authority in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

**The following were present.**

Respondent : PIO-cum-PD, DRDA, Daporijo attended through VC.

## JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tasi Chader on **14/12/2022** filed an RTI application under Form-'A' before the PIO-cum-Project Director, DRDA, Daporijo, Upper Subansiri District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **19.01.2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **09.03.2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 220/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 16(sixteen) times i.e on 03/04/2023, 27/04/2023, 15/05/2023, 05/06/2023, 04/09/2023, 09/10/2023, 04/12/2023, 22/01/2024, 10/04/2024, 12/06/2024, 31/07/2024, 04/09/2024, 09/10/2024, 20/11/2024, 18/12/2024 and 23/04/2025. In this hearing of the appeal on 23<sup>rd</sup> day of April, 2025, the PIO-cum- Project Director, DRDA, Daporijo attended the hearing through VC but the appellant Shri Tasi Chader found absent.

As per the case record, on the last hearing dated 18/12/2024, the appellant was given opportunity to submit in writing why he is not satisfied with the documents provided and what are the documents he is not been provided till date. But the appellant has not given any such submission in writing to the PIO or before the Commission. Moreover, the appellant has submitted a letter addressed to the Chief Information Commissioner requesting to dispose off the Appeal Case No. APIC-200/2023.

Therefore, the Commission deems that the appellant is satisfied and has received the information which he has sought for.

Therefore, the Commission deems fit to dispose off this appeal case No. APIC-220/2023 and close. Accordingly, the appeal case is disposed off and closed.
