**JUDGEMENT**

This is an appeal filed under sub-section (3) of Section 19 of the RTI 2005. Brief fact of the case is that the Appellant Shri Serpi Flago on **03/10/2024** filed an RTI application in Form 'A' before the PIO-cum-EE, RWD, Raga Division, Kamle District, Govt. of Arunachal Pradesh. Whereby seeking various information as quoted in Form 'A' application. The Appellant being not receiving the information from the PIO filed the First Appeal before the First Appellate Authority (FAA) on **28/11/2024**, and even then, the Appellant not receiving the required information from the PIO, filed the Second Appeal before the Arunachal Pradesh Information Commission on **04/02/2025** and the Registry of the Commission (APIC) having receipt of the Appeal registered it as APIC-No. **07/2025** (Appeal) and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission on **08.05.2025, 19.08.2025 & 25.11.2025** wherein the Appellant found consecutively absent during the 2<sup>nd</sup> hearing on 19.08.2025, and in the 3<sup>rd</sup> hearing on 25.11.2025, without intimating the reasons for his absence to the Commission.

The PIO-cum-EE, RWD, Raga Division, Kamle District, Govt. of Arunachal Pradesh is represented by Shri Tami Hokam, Assistant Engineer, RWD, Raga Division, as the PIO is on election duty.

The Appellant absent consecutively absent in the 2<sup>nd</sup> hearing and 3<sup>rd</sup> hearing despite notice issued from the Arunachal Pradesh Information Commission for hearing on 08.05.2025 and 19.08.2025.

Heard the representative of the PIO;

The representative of the PIO stated that all the information sought by the Appellant have been provided to the Appellant from the side of the PIO on 08.05.2025 in person.

After hearing the representative of the PIO the Commission hereby observes;

1. The information(s) have been provided to the Appellant by the PIO on 8<sup>th</sup> day of May' 2025.
2. The Commission presumes that being in receipt of the information from the PIO the Appellant has not bothered to attend the hearing for his appeal without intimating the reason for his absence despite notices for presenting himself in the hearing given to him repeatedly.
3. The repeated absence of the Appellant exhibits insincerity as well as no seriousness of pursuing his appeal and also disregarding the notice of the Arunachal Pradesh Information Commission (APIC).

4. The absence of the Appellant also signified his disrespect to the laid down procedural laws of the country and the procedural laws of the RTI, Act, 2005.

Under the above stated facts and circumstances the Commission hereby orders;

- i) Pursuant to the repeated and consecutive absence of the Appellant despite repeated notice of hearing served by the Commission, the Commission hereby dismiss this appeal ex-parte.
- ii) And, therefore, this instant appeal is dismissed with no liberty given to the Appellant to file fresh application for the same set of information from the same office of the PIO.

**Order:**

In view of the above facts and circumstance the Commission dismiss this Appeal ex-parte. And, accordingly, this Appeal stands dismissed and closed once for all.
