Information sought :

The complainant file a RTI Application dated 25/02/2025 seeking Details regarding Year-wise details for the last 5 (five) years from 2021 to 2026 of power purchased for supply to consumers.

As per the case record, PIO did not furnish the sought information.

.Feeling aggrieved and dissatisfied by the order of the FAA, complainant approached the Commission with instant complaint case.

JUDGEMENT ORDER

This is complaint filed under sub-section (1) of Section 18 of the RTI Act, 2005. Brief fact of the case is that the complainant Shri Bengia Jayanta on **25/02/2025** filed an RTI application under Form-'A' before the PIO-cum-EE (Power), Naharlagun Electrical Division, Papum Pare District, Govt. of Arunachal Pradesh whereby, seeking various

information, as quoted in Form-A application. The Complainant, being not satisfied with the information received from the PIO, filed the Second Complaint before the Arunachal Pradesh Information Commission on **25/05/2026** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 12/C/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for one time i.e on 24/08/2026. In this hearing of the appeal on **24th day of August, 2026**, PIO-cum-EE (Power), Naharlagun Division and the complainant Shri Bengia Jayanta present in person.

The complainant has stated that he has made complaint under Section 18 (1) of the RTI Act.

Complainant has requested that he may be allowed to withdraw the complaint application as the sought information has already been furnished by the PIO.

Request is accepted. Accordingly, the complaint case is disposed of and closed.
