JUDGEMENT ORDER

This is an appeal under section 19(3) of RTI Act, 2005 was received from **Shri Tania June, C/o Hotel Chandini Naharlagun, Arunachal Pradesh**, for non-furnishing of information, by **the PIO-cum-EE, Dept. of Power Namsai division, Namsai District, Govt. of Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 02.06.2022 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

"To furnish the details of the New 33/11 KV S/Stn., New 33 KV line, DTRs, 11 KV line, LT line and New 11 KV Bay, Cost of Rs.37.56 lakhs."

The above subject has been mentioned in detail under 'Form – A'.

The 1st hearing for the case was held on the 11th day of Nov'2022. The appellant was present. The PIO was also present. After hearing both the parties, the PIO informed the Court/Commission that information sought by appellant was already provided through Dak and has requested the appellant to pay the amount in Treasury Challan. Also, another hard copy was brought by PIO and furnished to the appellant during the court proceedings itself. The appellant received the same and assured to pay in Treasury Challan the amount. The appellant was directed by the Court/Commission to go through the same and express his satisfaction/dissatisfaction on or before the next date of hearing of this case. Later, the appellant expressed his satisfaction with the information provided by the PIO and requested before the Court to dispose the Case/Appeal. Hence, the case is disposed of.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
