JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Dawa Tsering on 31/01/2025, filed an RTI application under Form-'A' before the PIO-Cum- o/c the Director of School Education Itanagar Govt, of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 23/06/2025 the Appellant, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 16/10/2025, and the Registry of the Commission (APIC), having receipt of the Appeal registered it as APIC No. 784/A/2025 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission on 07/04/2025.

Details of information applied;

Furnish name list of all man regular staff currently serving under Director of Secondary Education in West Kameng District DDSE, with their post, years record of serving, salary Details, current posted village/town.

- i) Furnish names of all regular staffs serving under Director of Secondary Education all over Arunachal Pradesh. Only for those who has address in their documents in (ST and PRC),(ADHAR CARD, PAN CARD, ELECTION CARD), for achievement of job belongs from West Kameng District, Dirang circle
- ii) Furnish phata copies of (ST or PRC) any 1 mandatory (ADHAR CARD, ELECTION CARD, PAN CARDI) any 1 mandatory, QUALIFICATION CERTIFICATE, APPOINTMENT LETTER, Interview video footage records, Advertisement to local newspaper, Names of all board members with board procedure resolution passed copy with attested in CTC.
- iii) Furnish all documents requested in CTC only and Furnish all requested documents period since 2018 January 1" to till date only.
- iv) Furnish all requested documents names with note pad stick on it for smooth understanding
- v) If any documents i requested is personal or other inappropriate reason, kindly for your acknowledgement go through with INDIAN EVIDENCE ACT sections in point no below or contact me, for your smooth understanding. So reply must be in written only

- vi) Furnish list of all regular staff with their Seniority wise, copy of (ST or PRC), (ADHAR CARD, FAN CARD, ELECTION CARD), Qualification certificate and Joining letter serving currently in DDSE west kameng Dist, A.P.
- vii) Furnish photo copies of all sanctioned orders approved by State & Central govt to Director of Secondary Education for DOSE and NGOs West Kameng District .A.P

In this hearing of the appeal on **7th day of April, 2026**, the Appellant Shri Dawa Tsering, found absent during the hearing and the PIO –cum Director of School Education (DDSE), Itanagar Govt. Of Arunachal Pradesh is present during the hearing.

However, the Appellant Shri Dawa Tsering, has submitted a letter through the official whats App number to the Commission on **6/04/2026**, stating that he has received all the information(s) as sought in his Form 'A' application and has requested the Commission for disposal/closure of his appeal on ground of satisfactorily in receipt of all information(s) sought from the PIO.

In view of the above facts and circumstances the Commission, find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed of and closed once for all.
