Information sought :

The appellant file a RTI Application dated 03/06/2025 seeking Details regarding :- C/o List of project/work executed during the year 2025-26 under PWD Dirang Division.

As per the case record, PIO has not provided information in time.

Being dissatisfied, the appellant filed First Appeal dated 11/07/2025. No hearing has been conducted by the First Appellate in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Tamchi Gungte absent.

Respondent : PIO-cum- EE(PWD), Dirang Division, West Kameng District present through VC.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tamchi Gungte on **03.06.2025** filed an RTI application under Form-'A' before the PIO-cum- Executive Engineer, Dept. of PWD, Dirang Division, West Kameng District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **11.07.2025**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **03.09.2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 687/A/2025(Appeal)** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 2 (two) time i.e on 11/02/2026 And 08/04/2026. In this hearing of the appeal on 8th day of April, 2026, the PIO is present through VC and appellant Shri Tamchi Gungte is found absent without any intimation to the Commission.

The appellant has been absent consecutively 2 (two) times on hearings dated 11/02/2026 and 8/04/2026. The PIO has stated that documents are ready to be furnished which is available before the FAA. The appellant never appeared to collect the documents sought inspite of giving repeated information. Therefore, the Commission presumes that the appellant has no more interest to persue this appeal case. Accordingly the appeal case No. APIC-687/A/2025(Appeal) is disposed of and closed.
