## JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Tamchi Gungte on filed an RTI application under Form-'A' before the PIO-Cum- Block Development Officer (BDO) Koloriang District Kurung Kummey, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **04/07/2023**, the Appellant, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **9/8/2023** and the Registry of the Commission, having receipt of the Appeal registered it as **APIC No. 766/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission three times i.e on 05/12/2024, 18/02/2025, & 8/07/2025, details of information(s) sought from the PIO.
