Information sought :

The appellant filed an RTI Application dated 29/08/2024 seeking Details regarding service record of Er. Nily Likha Kamin since appointment.

As per the case record, PIO did not furnish the sought documents.

Being dissatisfied, the appellant filed First Appeal dated 14/10/2024. No hearing was conducted by the First Appellate Authority in his jurisdiction. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Khya Changrang absent.
Respondent : PIO-cum-SE (PWD) attended the hearing through VC.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Khya Changrang on **29.08.2024** filed an RTI application under Form-'A' before the PIO-cum-Superintendent Engineer (PWD), O/o Chief Engineer (PWD), Western Zone, Itanagar, Papum Pare District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **14.10.2024**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **21.11.2024** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 358/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for seven times i.e on 12/03/2025, 21/04/2025, 09/06/2025, 20/08/2025, 08/12/2025, 04/02/2026 and 18/05/2026 In this hearing of the appeal on 18th day of May, 2026, the PIO-cum-SE (PWD), O/o Chief Engineer (PWD), Western Zone attended the hearing through VC but the Appellant found absent, however, sent a letter addressed to the Commission requested to dispose of the appeal case NO. APIC-358/2024.

Request accepted and the appeal case is disposed of and closed.
