JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI 2005. Brief fact of the case is that the Appellants, Shri Palen Laa and others on **20/06/2023** filed an RTI application in form 'A' before the PIO-cum-EE, Power (E), Raga Division, Kamle District, Govt. of Arunachal Pradesh. Whereby seeking various information as quoted in Form 'A' application. The Appellants being not furnished with the required information(s) from the PIO filed the First Appeal before the First Appellate Authority (FAA) on **24/07/2023**. Appellants again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **28/08/2023** and the Registry of the Commission (APIC) having receipt of the Appeal registered it as APIC-No. **829/2023** (Appeal) and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission on **12/11/2024, 16.01.2025, 07.08.2025, 18.11.2025, & 26.03.2026.**

Details of Information sought from the PIO;

1. Please furnish appointment order copies.
2. Furnish work joining report copies.
3. Furnish for the post of advertisement in local news paper.
4. Furnish education qualification certificate copies.
5. Furnish seniority list copies.
6. Furnish DPC & Board member details name list copies.
7. Furnish DPR copies.
8. Furnish Govt approval sanction order copies.
9. Furnish MLA/ Minister notesheet copies.
10. Furnish ST/PRC/Aadhaar card Xerox copies.
11. Furnish date, year, day, time and place of the interview copies.
12. Furnish result declaration copies.

Period from which information asked for: 2014 to till date.

The Appellants Shri Palen Laa & Smti. Yugar Yaga absent without informing their reason for their absence in today's hearing consecutively for the 2nd time.

It is to be noted that both the Appellants were absent in the last hearing that is the 4th hearing which was held on 18.11.2025 despite notice for hearing served unto them on 07.08.2025 and 18.11.2025.

In the 4th hearing held on 18.11.2025 the Appellants absent without informing the reason for their absence to the Commission.

The PIO-cum-EE, Power (E), Raga Division, Kamle District, Govt. of Arunachal Pradesh represented by Shri Thar Takap, Junior Engineer (JE), Power (E), Raga Division stated before the Commission that whatever information(s) available with the office of the PIO have been provided to the Appellant.

After going through the Form-A application of the Appellant, and seeing the consecutive absence of the Appellants to attend the hearing, the Commission hereby pass the below orders;

- i) In the continued absence of the Appellants despite being notified of the hearing, the Arunachal Pradesh Information Commission (APIC) hereby consider their absence as being non serious on their appeal and rather an attempt to harass the PIO which is supposedly their vested interest rather than public interest.
- ii) Considering the submission of the PIO that all the information(s) have been provided to the Appellants, this Commission hereby disposed of this appeal ex-parte.

In view of the above facts and circumstances the Commission, find this appeal fit to be disposed of and closed. And accordingly this appeal stands disposed of and closed once for all.
