Information sought :

The appellant file an RTI Application dated 03/05/2024 seeking Details regarding Creation of Artificial Regeneration plantation at Passa Village amount of Rs. 24.78 lakhs. Soil moisture conservation at Gumte area under Passa Village amount of Rs. 39.07 lakhs.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 28/05/2024. First Appellate Authority has conducted the in his jurisdiction on 26/06/2024. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tabing Lamgu **03.05.2024** filed an RTI application under Form-'A' before the PIO-cum-Divisional Forest Officer, Khellong Forest Division, West Kameng District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **28.05.2024**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **09.09.2024** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 250/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 6(six) times i.e on 05/03/2025, 05/05/2025, 18/08/2025, 29/09/2025, 09/03/2026 and 13/04/2026. In this hearing of the appeal on **13th day of April, 2026**, the PIO-cum-DFO, Khellong Forest Division attended the hearing through VC but the appellant Shri Tabing Lamgu found absent without any intimation to the Commission.

As per the order dated 13/04/2026, the appellant has been provided all the information through his e-mail address as well as his new postal address. The appellant was directed to intimate whether the documents has been received or not. The appellant was cautioned that if no intimation is made the Commission will presume that he got all the information and is satisfied. Sufficient time has been given to the appellant. Therefore, the Commission presumes that appellant has received all the information and satisfied.

The Commission deems fit to dispose of this appeal case. The appeal case No. APIC-250/2024 is disposed of and closed.
