**ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tarh Ravan & Karan Veo, Rakap Sanglum village, near Pachin Colony, Naharlagun, Papum Pare District, Arunachal Pradesh for non-furnishing of information by the SPIO-cum- District Fisheries Development Officer (DFDO), Govt. of A.P. Department of Fisheries, Bomdila, West Kameng District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 25/04/2023 regarding **Fishery scheme under Blue Revolution, BR, RKVY, MMNKA & SADA.**

**The 2<sup>nd</sup> hearing held today on 16<sup>th</sup> January' 2024 (Tuesday) at 1030 hrs,** the PIO Shri N.C. Adak, PIO-Cum- DFDO, Bomdila is present. The Appellant Shri Tarh Ravan is absent. During the 1<sup>st</sup> hearing i.e on 31<sup>st</sup> October' 2023 (Tuesday), the APIO has furnished the authenticated copy of information to the Appellant in the Court room of the Commission. The Appellant received the information and sought time for verification of the same and assured that if information are found correct and satisfied, he will inform the commission for disposing of the case. The Commission giving reasonable opportunity to the Appellant adjourned the court for the next date of hearing.

During the 1<sup>st</sup> hearing i.e 31<sup>st</sup> October' 2023 it was clearly directed both the parties to be present today's court hearing, but the Appellant is found absent. If the SPIO is found absent the Commission may initiate penal provisions and in case Appellant is found absent the case shall be disposed of without any further notice, presuming that the Appellant is satisfied with the information so furnished.

The non appearance of the appellant shows that he is satisfied with the information so furnished.

**Therefore, the case is disposed of and closed.**
