**JUDGEMENT**

This is an appeal filed under sub-section (3) of Section 19 of the RTI 2005. Brief fact of the case is that the Appellant Shri Aru Laa on **01/09/2025** filed an RTI application in Form- 'A' before the PIO of the office of the Chief Engineer, PWD (CSQ), Capital Complex, Itanagar, Papumpare District, Govt. of Arunachal Pradesh. Whereby seeking various information as quoted in Form 'A' application. The Appellant being not receiving the information from the PIO filed the First Appeal before the First Appellate Authority (FAA) on **03/10/2025**, and even then, the Appellant not receiving the required information from the PIO, filed the Second Appeal before the Arunachal Pradesh Information Commission on **14/11/2025** and the Registry of the Commission (APIC) having receipt of the Appeal registered it as APIC-No. **854/A/2025** (Appeal) and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission on **07.04.2026** wherein both the parties present during the hearing before the Commission.

**Heard the Appellant;**

The Appellant stated that the PIO has not provided him the information as applied for.

**Heard the PIO;**

The PIO stated that the information that the Appellant has applied are to be furnished by a particular officer who is the Superintending Engineer (SE) CSQ, and I have written a letter to that particular officer to furnish the information, for which he is yet to provide me the information, and therefore, this delay in furnishing the information to the Appellant.

After hearing both the parties the Commission minutely observes the appeal and its contents and find that;

- i) The information as sought by the Appellant falls under THIRD PARTY information and third party information cannot be provided directly by the PIO

without obtaining the permission from the third party, except in the case wherein the providing of the information outweigh the permission of the third party in the public interest.

- ii) After the above prudent observations the Commission hereby orders;
- As the information applied by the Appellant needs the prior permission of the third party.
  - The PIO is hereby ordered to write to the proprietor of M/s Sunrise Enterprise asking for the permission to provide his personal information to the Appellant or not.
  - The copy/reply from M/s Sunrise Enterprise to be furnished to the Appellant Shri Aru Laa, Village Laa, PO; Boasimla, PS; Raga, Kamle District, Mobile No. 9612211515.
  - In the event of the third party permitting the furnishing of the information it be given to the Appellant.

With the above order the appeal is hereby disposed of.

In view of the above facts and circumstances the Commission dispose of this Appeal. And, accordingly, this Appeal stands disposed of and closed once for all.
