An Appeal Case U/S 19(3) of RTI Act, 2005
Case No. APIC-328/2026.

APPELLANT : Shri Bengia Papo, Akum Hapa colony, Chimpu-III
RESPONDENT : The PIO, o/o the Project Director Samagra Shiksha, Itanagar.

ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri RatanChetia for non-furnishing of below mentioned information by the PIO, o/o the Project Director Samagra Shiksha Itanagar (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 23.01.2026.

A. Details of Information:

1. Furnish all the JE list of all the Districts of Arunachal Pradesh with their appointment order and mention their posting place in details.
2. Furnish the appointment order copy of JE of Shri Lokam Loring and Shri Lindum Pacha who have appointed as JE under your department and also mention their place of posting.
3. Furnish the 35 illegal appointed Employee list, along with their appointment order copy and mention the place of posting, then appointed employees by shri Nangra Pingkap, APCS and Shri Nellam Tan APCS.
4. Furnish the appointment order copy of Miss Taba Yangam.
5. Furnish all the MTS Staff list with appointment order copy and mention their place of posting.

B. Period for which information asked for: - 2019 to till date.

Brief facts emerging from the appeal :

Records emerging from the appeal disclose that the appellant, Shri Bengia Papo had requested the PIO for the aforementioned information/documents but failed to obtain the same which prompted him to appeal before the State Project Director, Samagra Shiksha, Govt. of A.P, Itanagar, the First Appellate Authority (FAA) under Section 19 (1) of the RTI Act, 2005 vide his Memo of Appeal dtd. 02.03.2026.

However, the FAA, apparently, did not consider the appeal which prompted the appellant to file his 2nd appeal before this Commission under section 19 (3) of the RTI Act. 2005 vide his Memo of appeal dt. 06.04.2026.

Hearing and decision:

This appeal is, accordingly, listed for hearing in this Commission today on 05.08.2026 wherein the appellant the PIO, Shri Sadung Gyado, Dy. State Project Director (SPD)-cum-PIO is present in person while the appellant is represented by Advocate Shri Bengia Tahar.

Heard the parties.

The PIO submitted that the recruitment of the JEs and the MTS for the Districts are done by the District offices concerned. He, however, stated that the Directorate has collected the requested documents from the Districts and vide letter dt. 8th July, 2026, the appellant was advised to collect the same. The documents/information brought in by the PIO has been handed over to the appellant's counsel during the course of hearing today.

This Commission, upon perusal of the information/replies so furnished to the appellant (as reproduced hereunder), finds that the same are sufficiently provided as requested by the appellant.

It is to inform you that the information required by you vide your application dated on 23/01/2026, is ready for collection. The information furnished to you as on today is of 3 (three) pages

You are requested to collect the information from this office at the earliest date. The information sought by you is as follows:

3	<i>Furnish the 35 (thirty five) illegal appointed employees lists along with their appointment order copy and mention the place of posting, then appointed employees by Shri Nangram Pingkap, APCS and Shri Nellam Tan, APCS.</i>	<i>Name list to furnish the list of those alleged irregular appointed JEs is required.</i>
4	<i>Furnish the appointment order copy of Miss Taba Yagam.</i>	<i>No such employee as Miss Taba Yagam is employed in the state office. To get the information, specification of the post held and the district where presently working is needed.</i>
