<u>ORDER</u>

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Nechang Kamki & Tarh Rohan for non-furnishing of below mentioned information by the PIO o/o the Under Secretary (RWD), Govt. of Arunachal Pradesh as sought for by them under section 6(1) (Form-A) of RTI Act, 2005 vide their application dated 07.11.2024.

- A) Particular of information: Maintenance of PMGSY road
- B) Details of information required:
- 1. The e Marg (Electronic Maintenance of rural road under PMGSY statement of above said project/Scheme) and
- 2. All bank authorization letter of above said project/scheme.
- C) Period for which information asked for: 2023 24

This appeal was listed and heard today on 23.04.205 for the second time, the first time being on 04.04.2025.

In the hearing on 04.04.2025 wherein the appellants, Shri Nechang Kamki & Tarh Rahan, Upper Niti Vihar, Itanagar were present in person but the PIO, the Under Secretary (RWD), who informed, vide letter dt.28.03.2025, that she had joined the present place of posting recently and such she is not fully acquainted with the works of the department, requested for some time to collate the sought for information. She also, stated in her letter that "the information requested by the appellants pertain to the subject being dealt with by the o/o the CE(RWD)(PMGSY), Itanagar and as such the RTI application was forwarded to the PIO, o/o the CE(RWD)(PMGSY), Govt. of A.P, Itanagar vide letter dt.13.03.2025 with a direction to furnish the information as sought for by the appellants."

During the hearing, the appellants were informed of the aforesaid letter of the Under Secretary (RWD) and this Commission decided to summon the PIO, o/o the CE (RWD) (PMGSY), Govt. of A.P, Itanagar also in the next hearing of the appeal which was adjourned to today on 23rd April, 2025.

In today's hearing Ms. Boa Yamik, the Under Secretary (RWD)-cum-PIO o/o the Secretary (RWD), Govt. of A.P, Civil Sectt. and the appellants Shri Nechang Kamki and Tarh Rohan were present in person while the PIO, o/o the Chief Engineer (RWD)(PMGSY), Govt. of A.P, Shri Deniel Pertin attended the hearing through VC.

Heard the parties.

The PIO, Ms. Boa Yamik submitted that as already intimated earlier vide her letter dt.28.03.2025, since the sought for information pertains to the subject matter being dealt with by the o/o the Chief Engineer (RWD)(PMGSY), the sought for information may be collected from the PIO, o/o the Chief Engineer (RWD)(PMGSY), Govt. of A.P, Shri Deneil Pertin, who has agreed to furnish the sought for information. He, however, submitted that since the sought for information is under the custody of the CE who is on leave, the PIO sought some time to collate and collect the documents.

This Commission, upon hearing the parties and considering the position as stated by the US(RWD)-cum-PIO, o/o the Secretary (RWD), decided to summon the PIO o/o the CE (RWD)(PMGSY) in all future hearing of this particular appeal and accordingly, directed him to furnish the sought for documents to the appellants within 2(two) weeks from 23.04.2025. The appellants are also directed to collect the documents and intimate the receipt of the same to this Commission within one week thereafter failing which this appeal shall stand closed without any further order/notice.
