O R D E R

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Chou Chali Simit, Village- Manfaiseng, PO – Nanam Shyam, Namsai District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-BDO, Chongkham CD Block, Chongkham, Namsai District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 19/02/2025 regarding MGNREGA 2020 to 2025.
- 2). The 1st hearing was held on 15th October' 2025. Shri Kenge Loya, PIO-cum-BDO, Chongkham CD Block, Chongkham, Namsai District, Arunachal Pradesh was present. The Appellant had appeared before the Commission through video conferencing.
- 3). The PIO submitted that since the information as sought were ready to be furnished, the Appellant was asked to deposit fee for the information but he failed to turn up.
- 4). The Commission after hearing the PIO had asked the Appellant to visit office of the PIO on 22nd October' 2025 and collect the information. The Appellant was also asked to intimate the Commission in writing, his satisfaction or dissatisfaction.
- 5). The Appellant was cautioned that, in case he fails to intimate to the Commission within fifteen days from the expiry of above date, the case would be disposed of.
- 6). Till date the Appellant has not given any intimation to the Commission. In view of the order dated 15th October' 2025 the Commission decides to dispose of the case.

7). Therefore, the case is hereby disposed of.
