JUDGEMENT ORDER

Brief fact of the case is that the appellants Miss Bengia Mamu on **07.09.2024** filed an RTI application under Form-'A' before the PIO-cum-Assistant Director, Textile & Handicraft, Pasighat, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **01.11.2024**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **01.12.2024** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 422/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for one time i.e on 07/07/2025. In this hearing of the appeal on 7th day of July, 2025, both the parties, PIO-cum-Asstt. Director, Textile & Handicraft, Pasighat and Miss Bengia Mama found absent. However, the appellant Miss Bengia Mama sent a letter requesting to dispose off the appeal case No. APIC-422/2024 as all the information sought has been received from the PIO and she is satisfied with the information provided.

Request accepted and the appeal case No. APIC-422/2024 is disposed off and closed.
