ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tania June, c/o of Post Office Naharlagun Arunachal Pradesh for non-furnishing of information by the SPIO-cum-DLRSO, Govt. of A.P. O/o Department of Land Settlement Officer, Ziro, Lower Subansiri District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 10/02/2023 regarding Expenditure and implementation of Trans Arunachal Highway (TAH) Land Compensation payment of Potin to Pamluk, entire Lower Subansiri District.

The 2nd hearing is held on 17th October, 2023 as scheduled. Shri C. Raja, the SPIO-Cum-DLRSO, Govt. of A.P. O/o Department of Land Settlement Officer, Ziro, Lower Subansiri District, Arunachal Pradesh alone is present. The Appellant Shri Tania June is found absent. The SPIO has presented some documents to hand over the Appellant and reiterated that all the information sought by the Appellant from Sl. No. 1 to 13 has been seized by the SIC. So, he has placed some documents copy of seizure list and other correspondences with investigation department and also submitted that whatever information is available in their control, has been given to the Appellant during the last hearing. Both the parties were directed to be present during the hearing but the Appellant is found absent.

Since there is no information in the office of the SPIO to be furnished to the Appellant except the seizure list and other correspondence which were already furnished to the appellant through postal services on 09/03/2023. On perusal of documents available and submission of the SPIO, the Commission is satisfied with the action taken by it. In absence of Appellant inspite of clear directions by the Commission, it decides to disposed of the appeal case.

Hence, the case is closed and disposed of.
