JUDGEMENT ORDER

This is an appeal under section 19(3) of RTI Act, 2005 was received from **Shri Dongru Tania, Near Takar Complex, Naharlagun, PO/PS-Naharlagun, Arunachal Pradesh**, for non-furnishing of information, by the **PIO-cum-EE, Hydropower Palin Division, Kra Daadi District, Govt. of Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 28.02.2023 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

"To furnish all the relevant documents regarding Expenditure & Implementation under SADA/ADA /RIDF/ SIDF/ RE/BE of entire Kra Daadi District for the year 2010 to 2023 (till date)."

The above subject has been mentioned in detail under 'Form – A'.

The 1st hearing for the case was held on the 21st day of Dec'2023. The PIO was absent but the appellant was absent and submitted an application (copy enclosed for ready references) intimating that he had received all the information as sought from the PIO-cum-EE, Hydropower Palin Division and is fully satisfied with the information provided by the PIO and also pleaded before the Court for the disposal of the case. Hence, the case is disposed of.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
