JUDGEMENT ORDER

An appeal under section 19(3) of RTI Act, 2005 was received from **Shri Bamang Tagung, Press Colony, Papunallah, PO/PS-Naharlagun, ICR, Arunachal Pradesh**, for non-furnishing of information, by **The PIO-cum-Executive Engineer, Water Resource Department, Itanagar Division, Itanagar Capital Region, Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 02.06.2022 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

"Details information of PMKSY(HKKP) under surface Minor Irrigation(SMI) Scheme for Financial Year: 2017, 2018, 2019, 2020".

The above subject has been mentioned in detail under 'Form – A'.

The 1st hearing was held on 27th day of September' 2022. The appellant was present but the PIO was absent. The case was heard ex-parte. Since the PIO was absent the matter couldn't be heard further. Hence, the Court fixed another date of hearing for the case on 16th November' 2022.

In-between, the Commission received a letter(enclosed) from the appellant whereby expressing his satisfaction for all the documents received & further pleaded for disposal off the case, as such the Court ordered to dispose off the case and no such hearings for the case will be entertained further in the Commission's Court.

Considering all the above aspects into account, I find this appeal fit to be disposed off as infructuous. And, accordingly, this appeal stands disposed off and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
