**JUDGEMENT**

This is an appeal filed under sub-section (3) of Section 19 of the RTI 2005. Brief fact of the case is that the Appellants, Shri Palen Laa and others on **23/06/2023** filed an RTI application in form 'A' before the PIO-cum-DPDO, Raga, Kamle District, Govt. of Arunachal Pradesh. Whereby seeking various information as quoted in Form 'A' application. The Appellants being not furnished with the required information(s) from the PIO, filed the First Appeal before the First Appellate Authority (FAA) on **24/07/2023**. Appellants again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **24/08/2023** and the Registry of the Commission (APIC) having receipt of the Appeal registered it as APIC- No. **819/2023** (Appeal) and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission on **12/11/2024, 16.01.2025, 07.08.2025, 18.11.2025, & 26.03.2026.**

**Details of Information sought from the PIO;**

- i) Furnish sanction order copies.
- ii) Furnish utilization certificate copies.
- iii) Furnish work completed photo copy and geo-tech copies.
- iv) Furnish DPR Copies.
- v) Furnish site inspection report copies.
- vi) Furnish fund transfer through PFMS copies.
- vii) Furnish name of contractor & farm names copies.
- viii) Furnish cheque amount release to contractor copies.
- ix) Furnish bill challan copies with voucher/cash memo copies.
- x) Furnish initial stage photo copies.
- xi) Furnish name of technical officer like JE etc.

**Period for which information asked for 2019 to till date.**

The Appellants Shri Palen Laa & Smti. Yukar Yaga absent without informing their reason for their absence in today's hearing consecutively for the 2<sup>nd</sup> time.

It is to be noted that both the Appellants were absent in the last hearing that is the 4<sup>th</sup> hearing which was held on 18.11.2025 despite notice for hearing served unto them on 07.08.2025 and 18.11.2025.

The PIO-cum-DPDO, Raga, Kamle District, Shri Pani Tapa is present through online mode during the hearing before the Commission.

**Heard the PIO;**

The PIO stated that all the information(s) that were not furnished to the Appellant have been furnished to them completely and yesterday also I have spoken to one of the Appellant regarding some issue and he admitted that he will be appearing in the court today.

After hearing the PIO-cum-DPDO, Raga, Kamle District, Govt. of Arunachal Pradesh, and seeing the consecutive absence of the Appellants to attend the hearing, the Commission hereby pass the below orders;

1. In the continued absence of the Appellants despite being notified of the hearing, the Arunachal Pradesh Information Commission (APIC) hereby consider their absence as being non serious on their appeal and rather an attempt to harass the PIO which is supposedly their vested interest rather than public interest in filing the Form-A itself.
2. Considering the submission of the PIO that all the information(s) have been provided to the Appellants, this Commission hereby dispose of this appeal ex-parte.

In view of the above facts and circumstances the Commission, find this appeal fit to be disposed of and closed. And accordingly this appeal stands disposed of and closed once for all.


