JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Tamchi Gungte on 24.03.2023 filed an RTI application under Form-'A' before the PIO-Cum- EE, RWD, Ziro, Division, Lower Subansiri District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 03.04.2023, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 01.06.2023 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 523/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the **Commission for 5 (five) times i.e on 03.07.2023, 28.08.2023, 04.10.2023, 13.11.2023 & 08.01.2023.** In this hearing of the appeal on 8th day of January,2024. The appellant Shri Tamchi Gungte and the PIO present during the hearing.

Heard both the parties.

The PIO intimated to the Commission that the appellant is mentioned the block year for the information in which no any project was sanctioned by the Government to the Department, due to which he could not furnish the information to the appellant as there is no such project was executed by the Department.

The Commission after hearing from both the parties and after going through all the available records/documents, the commission explained the matter to the appellant. Since, the Form 'A' application in which block mentioned by the appellant during the period/block year no any project is received or executed any project by the Department, so no question of furnishing the information. Therefore, this APIC-523/2023 appeal is meaningless to continue hearing. On the ground as mentioned above fact the appellant

understood the fault in his application. So, after understanding the matter, the appellant has submitted a letter to the Commission during the hearing due to confusion of the Block Year of the scheme which he failed to mention the correct block year in his form 'A' application. So, he has requested the Commission for disposal/closer of his appeal on the ground of the judgment satisfactory passed by the Commission. However, the Commission given the liberty to the appellant appeal a fresh appeal by mentioning correct block year of the information which he wants to sought from the PIO if he required the information. On this, the appellant agreed and he has requested the Commission for disposal/closer of his appeal on the ground of satisfactorily judgment passed by the Commission .

In view of the above facts and circumstances, I find this appeal fit to be disposed of and closed. And, accordingly, this appeal stands disposed of and closed for once for all.
