# JUDGEMENT ORDER

-V/S-

This is an appeal under section 19(3) of RTI Act, 2005 was received from Shri Dongru Tania, Near Takar Complex, Naharlagun, PO/PS-Naharlagun, Arunachal Pradesh, for non-furnishing of information, by the PIO–cum-EE, PWD Palin Division, Kra Daadi District, Govt. of Arunachal Pradesh, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 28.02.2023 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

"To furnish all the relevant documents regarding Expenditure & Implementation under SADA/ADA /RIDF/ SIDF/ RE/BE/ UNITED FUND of entire Kra Daadi District for the year 2010 to 2023 (till date)."

## The above subject has been mentioned in detail under 'Form -A'.

The 1<sup>st</sup> hearing of this case was held on the 21<sup>st</sup> day of Dec'2023. Both the parties were present. After hearing both the parties, the Court directed the PIO to provide only the Sanction Order pertaining to SIDF Schemes only from 2017 to the filing of this case on or before the next date of hearing of this case fixed on the 24<sup>th</sup> day of January'2024.

The 2<sup>nd</sup> hearing for the case was held on the 24<sup>th</sup> day of January'2024. The appellant was absent; however, he had submitted an application intimating his inability to attend the hearing. The PIO was present and informed the Court/Commission that he had furnished the information to the appellant as directed by the Court/Commission in its previous hearing. Hence, the case is disposed of.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all.
