ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Nabam Nanu for non-furnishing of below mentioned information by the PIO, o/o the District Panchayat Development Officer Papum Pare District Yupia (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 02.06.2025:

Brief facts emerging from the appeal:

Records in the appeal disclose that the Appellant had sought the aforementioned information/documents from the PIO but, apparently, failed to obtain the same which prompted him to file his 1st appeal under section 19(1) of the RTI Act before the Deputy Commissioner, Papum Pare District, Yupia, the First Appellate Authority (FAA) vide his Memo of Appeal dt.08.07.2025.

Records further reveal that the FAA conducted hearing on 08.10.2025 and the FAA, vide order dt. 08.10.26, as reproduced below, closed the appeal holding that the PIO had furnished all the available documents to the appellant:

The appellant, however, preferred his 2nd appeal before this Commission under section 19(3) of the RTI Act vide his Memo dt.13.11.2025.

Hearing and decision:

This appeal was, accordingly, listed and heard on 25.03.2026 wherein the appellant, Shri Nabam Nanu and Ms. Tame Yajum, the ADC-cum-DPDO, Papum Pare District were present in person.

Heard the parties.

The appellant submitted that the o/o the DC, Yupia, the FAA, vide letter dt.08.09.2025, furnished the requested information / documents but complained that the documents/information were either incomplete or /and were not properly paged or indexed and as such pleaded for an appropriate direction to the PIO to furnish the requested information with proper paging. The appellant, however, could not specifically point out as to the replies which are incomplete. The PIO, on the other hand, submitted that since the appellant had collected the information from the First Appellate Authority and not from the o/o the PIO, it would not be possible on the part of the o/o the PIO to confirm / acknowledge the shortcoming in the replies /information received by the appellant. The PIO, however, submitted that the appellant shall be provided with whatever documents/information are available in the o/o the PIO and shall also explain the shortcoming, if any, therein, provided, the appellant submits specific point(s) of his dissatisfaction to the o/o the PIO. During the course of hearing the PIO also furnished the following written statement dt.24.03.2026, containing the details of replies/information furnished to the appellant:

The PIO was, however, directed to furnish the point-wise information/replies with proper page marking and indexing in a tabular form to the appellant to his satisfaction and the appellant was also directed to visit the o/o the PIO and inspect the documents/records as is entitled to under section 2(j)(i) of the RTI Act, 2005.

The parties were, thus, directed to comply with the above order and report compliance therewith with 3(three) weeks from the date of receipt of order dt.25.03.26.

This Commission notices that the parties have received and seen this Commission's aforesaid order on 27.03.2026 (through Whatsapp) and it is presumed that they have duly complied with the direction warranting no further adjudication of this appeal in this Commission. Resultantly, this appeal stands disposed of and closed.
