**Information sought:**

The appellant filed an RTI application dated 03.10.2024 seeking following information regarding **C/o "Integrated infrastructure Development for Tourism at Tawang with the provision of sewage and water treatment plant at Tawang District,** under the North East Special Infrastructure

Development Scheme (NESIDS) in Arunachal Pradesh during the financial year 2020-21.

Particulars of sought information:

1. Furnish the Certified copy of Integrity Pact submitted by the tender participant.
2. Furnish the certified copy of Work Specification of the project.
3. Furnish the certified copy of Design and Scope of the project.
4. Furnish the certified copy of EMD and Security money deposited by all the tender participant.
5. Furnish the certified copy of Completed three similar work each of value not less than 40% of the estimate cost or Completed two similar work each of value not less than 60% of the estimated cost or completed one similar work of value not less than 80% of the estimated cost in the last 5 years ending last day of the month previous to the one in which the tender are invited.
6. Furnish the certified copy of Documents submitted by the tender participants for Technical Bid in the tender process.

The following were present.

**Appellant** : Present. He states that he has sent the RTI application by post and he has produced a copy tracking consignment record also.

**Respondent PIO** : Represented by Shri Doge Kamduk, AE cum APIO. He states that he has not received any RTI application about APIC-No.11/2025 (Appeal)

**FAA** : Absent.

**Decision:**

The Commission after adverting to the facts and circumstances of the case, hearing the parties and perusal of the records, observes that FAA has not disposed of the first appeal filed to him.

*As laid down at para-38 of the Guidelines for the FAA issued by the GoI and the State Govt. OM No. AR-111/2008 Dated 21<sup>st</sup> August, 2008, adjudication on the appeals under RTI Act is a quasi-judicial function. It is, therefore, necessary that the Appellate Authority should see to it that the justice is not only done but it should also appear to have been done. In order to do so, the order passed by the appellate authority should be a speaking order giving justification for the decision arrived at.*

A copy of first appeal with RTI application in form – A is enclosed herewith.

Therefore, the instant appeal case is remanded to First Appellate Authority. Therefore, the **FAA – Superintending Engineer (SE) Rupa Circle, PHED, Department Rupa West Kameng, AP.**, following the principle of natural justice,

shall conduct hearing giving fair and equal opportunity to both the appellant and the PIO and thereafter pass reasoned and speaking order on merit within two weeks from the date of receipt of this order i.e **on or before 15.04.2025.**

The appellant is at liberty to file 2<sup>nd</sup> appeal afresh if not satisfied with the decision of the FAA / or PIO has not provided satisfactory information after order issued by the FAA. Fee for such 2<sup>nd</sup> appeal, if done, shall be exempted.

**The appeal is disposed of accordingly at Commission.**
